Bio

Patrick McKay is a Colorado attorney and 2012 graduate of Regent University School of Law in Virginia. He developed an interest in copyright and internet law in college and became an activist opposing misuses of copyright to stifle speech online. While in law school, he served as president of the Regent Intellectual Property and Entertainment Law Society for two years. He was also a member of the Regent Law Review, for which he wrote and published an article about copyright, fair use, and fan-made media including fan-fiction and fan-films. In the summer of 2011, he interned as a law clerk for the Center for Democracy and Technology in Washington D.C., during which he drafted a complaint to the Federal Trade Commission which helped expose a company that was abusing copyright law to suppress negative online reviews of physicians.

Patrick is an avid YouTube user and has enjoyed creating music videos and mashups as a hobby for many years. Since YouTube first instituted its automated Content ID copyright filtering system in 2007, he has been concerned about the potential for automated copyright enforcement systems to stifle legitimate speech which makes fair use of copyrighted material. He encountered this problem first-hand in early 2009 when YouTube blocked all videos using music from Warner Music Group during a licensing dispute. After successfully disputing copyright blocks on his own videos by arguing that they were fair use, Patrick began to help other users dispute copyright blocks on their videos.

In the spring of 2010, he created the website FairUseTube.org, designed to encourage online video creators to take advantage of their fair use rights and to provide tutorials for how to navigate YouTube's often confusing copyright dispute processes. In June 2011, he won a video contest hosted by the online civil rights group Public Knowledge, calling for responses to YouTube's mandatory "copyright school" video, which all users accused of copyright infringement were required to watch. Patrick has since dedicated his time to promoting awareness of the flaws in YouTube's Content ID system, which allows copyright claimants to

judge disputes against their own claims. He has been interviewed or cited in articles by Wired, TorrentFreak, and Ars Technica about abuses of this technology to illegitimately suppress or profit from videos which the claimant has no rights to. Patrick believes the growing abuse of YouTube's Content ID system is indicative of what happens when automated filters are substituted for human judgment when enforcing copyright laws. Without adequate safeguards and genuine opportunities for users to dispute false copyright claims, automated copyright enforcement poses a significant danger to free speech online.
